Rules for 2012 Outstanding Young Farmer**

**INSTRUCTIONS**

This is a protected version of the Young Farmer Application and Entry Form. You will only be able to type in your answers. You will not be able to change any part of the form. To get to the shaded blocks to type in your answers, you will hit the tab button. Then you will tab each time to get to the next block. You will only be able to type a **limited amount** in some of the blocks. When you are finished with your application, please take to your local County Farm Bureau and have the county president to sign the application. We need the original application mailed to us.

**Background**

The Tennessee Farm Bureau Federation annually conducts a Young Farmers & Ranchers Achievement Award competitive event. County Farm Bureaus are encouraged to promote this activity among young farmers. Selection of the winning Young Farmers & Ranchers competitor is based on his/her efforts in production agriculture and leadership achievement. Participation in this program with individual recognition and the resulting publicity will help build the organization. **The ideal candidate(s) for the Achievement Award is an individual or couple involved in production agriculture with a majority of their income subject to normal production risks.** It is recommended that the county Farm Bureaus provide, as part of the county recognition and award, an expense-paid trip to the TFBF Young Farmers Summer Conference in Columbia, TN on July 20-21, 2012. Appropriate recognition will be given to all the county competitors in attendance at the TFBF Young Farmers Summer Conference. The TFBF Young Farmers & Ranchers committee and the TFBF Special Programs Department will coordinate the program at the state level.

**Eligibility**

Competitors must meet the following criteria to compete.

- Members in good standing with their county Farm Bureau.
- Competitors shall be an individual or a married couple (husband & wife).
- Competitors shall be Farm Bureau members between the ages of 18 and 35 years of age. Individual or spouse shall not have reached their 36<sup>th</sup> birthday by January 31<sup>st</sup> after the AFBF Annual Meeting at which the competitive event is held. If spouse is over 35 years of age, the applicant must apply as an individual.
- Past and present members of the AFBF Young Farmers & Ranchers Committee or their spouses, and current members of the TN YF&R Committee are not eligible to compete.
- Competitors must be actively engaged in farming or ranching with the majority of income coming from production agriculture.
- Past state YF&R Achievement Award winners, and/or previous AFBF Achievement Award competitors are not eligible to compete.
- County, State and National Farm Bureau employees are not eligible; this also includes affiliate companies.
- Competitors may only compete in 1 national YF&R competitive event per year.

The Tennessee Farm Bureau YF&R Achievement Award recognizes both husband and wife in this competitive event. This is derived from the names on the applicant line. If the applicant is married, but only one of the partners is eligible, do not include any details concerning the spouse. Each county may submit one entry to be considered for state recognition. Applications of each county winner must be submitted using the TFBF entry form and application.

**Entry Form & Application Guidelines**

- Do not use your name, your county, or any names that may bring about the recognition or identification of your county beyond the entry form (page 3).
- The entry form and application must be in 10-point Times New Roman.
- Do not use abbreviations or acronyms.
- Recreating the application on a computer is not allowed. This includes no font or format changes, including bolding.
- Application must be properly signed with no additional pages.
- Letter of recommendation, scrapbooks or other visual additions will be terms for disqualification.
- During the interview process, do not use your name, your county or any names that may bring about the recognition or identification of your county.
- Only the named applicant(s) on the entry form are permitted into the interview.
- Counties have permission to reproduce the attached application form.

**Note: Disregarding any of the guidelines listed above will result in disqualification.**

### **Judging**

- A panel of qualified judges will select the district and state winners.
- The application and entry form of each county winner will be coded upon receipt by TFBF. Applicant's name and county will not be revealed to the judges until they are finished judging the application.
- The Top 10 competitors will be interviewed by the same three judges who reviewed the written applications.
- Interviews will be up to 15 minutes in length and are intended to clear up any "gray areas" which may arise from the written application.
- If you become a top 10 finalist your interview is for verification/clarification purposes and it may affect your final ranking.
- Interviews will be held during the TFBF Young Farmers Summer Conference.
- Values used in judging the applications will be:

Financial Progress of Operation	30 points
Farm Bureau Leadership	20 points
Other Leadership	15 points

- Judging is based on the application forms sent to the TFBF by the county Farm Bureaus and the clarifying interview held at the TFBF Young Farmers Summer Conference.
- Information contained in the entry form and application is considered confidential.

### **Deadline**

Counties are encouraged to select their winners in time for recognition at their county Annual Meeting. Each county winner's application must be in the Tennessee Farm Bureau office **on or postmarked by 4:45 p.m. CST May 15, 2012** to be considered for state recognition and awards.
